Selection Criteria for Chest Physician :-

- 1. Registration:
 - a) Chest Physician should be duly registered under appropriate authority and eligible to work in the area of Corporation.
 - b) He/She must have appropriate Educational Qualification to conduct the procedures from recognized institution.
 - c) He/She should have experience of working for atleast three years.
 - d) He/She blacklisted or place under funding restrictions by any Ministry or Department of the Government of India, State Government or CAPART would not be eligible for applying under the scheme.
 - e) Selection process be done for those who quotes the lowest rate of procedure.
 - f) He/She should adhere to NTEP Guidelines.
 - g) All rights of selection is reserved with Hon. Commissioner, Ulhasnagar Municipal Corporation.
 - h) Role of Private Practitioner as DR-TB Nodal Person.
 - 2. Experience:
 - a. Minimum 3 to 5 years experience in district level projects in health sector.
 - b. Experience of working in urban settings.
 - c. Prior work experience is similar project desired.
 - d. Experienced personnel.
 - e. All rights related to selection.
 - f. Willing to work for the period of minimum One Year.
 - g. Undergo Training if required & adhere to RNTCP guidelines. Maintain records & reports as given by NTEP .
 - 3. Financial:
 - a. Honorarium of Rs. 2500/- per visit (including consultations, emergency calls & travel cost to the centre)
 - b. Chest Specialist should be available for upto 2 visits per week or more as per requirements.
 - c. Chest Specialist should also be available for visits of any duration to attend emergency calls (Actual number of visits will be finalized by City T.B. Officer as per requirement).
